Sid Lentz asked, "Can you update the total number of deaths in assisted living/nursing homes out of the total number of deaths?" I'd been tracking deaths and cases over time globally, in USA, NY, NJ, County and Franklin. I added the most recent long term care (LTC) data. Please recall the inaccuracies I discussed in the LTC data (link below). Given that caveat, LTCs accounts for 73% of Franklin deaths and 28% of the cases attributed to COVID 19.

The LTC issue is a Franklin, County, State and National problem. Franklin has been monitoring the local situation and reporting it to the State which is the controlling authority and the County which also monitors. We have filled all PPE requests we had the capacity to fill. The State has called in the National Guard and has allowed student nurses to work in the facilities. It is a terrible problem.
